

 - ✓ All dogs entering UKC events must be permanently registered, or have a valid Temporary Listing Number, or Limited Privilege number. Dog not UKC registered? Go online to www.ukcdogs.com or call the Dog Events Department at (269) 343-9020.
 - ✓ All entry forms must be completed and signed. Incorrect information submitted on the entry form may invalidate your results for the trial(s).
