We will work on pooling odor, distractors, converging odor, strategies to offer best access to odor in many different container configurations, and supporting your dog in making the right decision. Topics covered include:

- Boxes, boxes, boxes
- Lines, rows, loops and circles
- Adding distractors and variety of containers
  - Multiple hides
  - Putting it all together

**Prerequisites:** Dogs should be able to source birch, anise and clove; dogs should be able to crate quietly either in the building or outside while waiting their turn
