Awards:

Awards will be handed out at the conclusion of each class. Ribbons will be awarded for qualifying score. New title rosettes will be awarded. High in Class and High in Trial rosettes will be awarded.

Venue:

Exhibitors will be crating dogs in their vehicles. 4 Paws / 4 Points reserve the right to remove any individual for any reason from the premises. No refunds will be issued. Please pack food and water for you and your dog.

Notice to Exhibitors:

- Trial will begin at 10:00am PT.
- Refunds will be processed via secreterrier.
- **No refunds will be made for cancellations after the closing or for entries which are absent, disqualified, excused, or barred from competition by decision of the Trial Committee.**
- Exhibitors are responsible for complete and accurate information on their entries.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs, children, and/or spectators. Any exhibitor whose dogs, children and/or spectator repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.
- All dogs must be on leash at all times, except when running a field class.
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- Please be courteous and pick-up after your dog.
- Bitches in season will run last and must wear protective garment.
- All entries must be accompanied by entry fees to be valid. **Your entry will be wait-listed by secreterrier if payment isn't provided upon entry.**
- 4 Paws / 4 Points reserve the right to refuse any entry without cause or explanation.
